## Board Addresses County Delinquent Property Tax Topic

An issue arose last year involving Loudon County’s requirement to auction property that is delinquent on County property tax rolls. State law requires all counties to sell delinquent properties at a tax sale in order to collect the taxes owed. Tellico Village has several hundred lots that are delinquent in terms of paying TVPOA assessments. Most of these lots are also delinquent with respect to county property taxes, so the result is that this issue affects both the Counties (Loudon and Monroe) and the TVPOA.

The issue results from the state law that requires a county to offer a starting bid at a tax sale equal to the total of all back taxes, fees, interest, etc. If no higher bid is offered, the county can end up in possession of the property. In 2010, an Appeals Court ruled that counties that acquire properties at a tax sale are then responsible for paying any applicable association dues or assessments that accrue during their ownership of such properties.

When this issue arose in 2012, your Board and General Manager worked closely with Loudon County officials to both seek a solution and to protect the rights of the TVPOA. No short term solution was obvious. In order to provide more time to seek a solution, Loudon County officials decided to pull the delinquent lots that were located in Tellico Village, and a few in other developments, out of the tax sale.

In 2013, several counties appealed to their state representatives to seek legislative relief from this potential obligation to pay association dues or assessments. In order to prevent legislation that could be detrimental to the TVPOA Covenants and Restrictions, we have closely monitored this activity. Members of the TVPOA Board and the General Manager have had several meetings, both locally and in Nashville, with Loudon County officials, Representative Matlock, Senator McNally, and State Comptroller’s General Counsel Robert Lee.

At this time, several bills have been filed in the legislature, but none of them offer a solution that is satisfactory to all parties. We will continue to be actively engaged in this process to assure that any legislation protects our interests.

## In the News

### Pa. groundhog's handler taking blame for forecast

PITTSBURGH (AP) — An Ohio prosecutor who light-heartedly filed a criminal indictment against the famous Pennsylvania groundhog who fraudulently "predicted" an early spring said he may consider a pardon now that the animal's handler is taking the blame.



Bill Deeley, president of the Punxsutawney Groundhog Club's Inner Circle, told The Associated Press on Monday that the animal rightly predicted six more weeks of winter last month, but he mistakenly announced an early spring because he failed to correctly interpret Phil's "groundhog-ese."

"I'm the guy that did it; I'll be the fall guy. It's not Phil's fault," Deeley said.

Butler County, Ohio, prosecutor Mike Gmoser told the AP that he's reconsidering the charges in light of the new evidence and may issue a full pardon.

"Frankly, he is a cute little rascal, a cute little thing," Gmoser said. "And if somebody is willing to step up to the plate and take the rap, I'm willing to listen."

The Groundhog Day celebration in Punxsutawney, a borough about 65 miles northeast of Pittsburgh, attracts worldwide attention each year. But the attention stretched well beyond Feb. 2 when Gmoser last week issued an indictment as winter-like weather continued across much of the nation even as spring began.

"Punxsutawney Phil did purposely, and with prior calculation and design cause the people to believe that spring would come early," Gmoser's indictment said. The penalty? Death, Smoser said, tongue firmly in cheek.

Deeley said this is the second year in a row he's misinterpreted Phil's forecast. "Remember, last year at this time it was 80 degrees and Phil had predicted six more weeks of winter," Deeley said.

Under normal circumstances, Deeley's interpretation of the forecast is infallible, as long as he clings to the gnarly, magical "Arcadian" cane while the rodent whispers the forecast into his ear. Deeley still doesn't know what went wrong, but he said the borough is nonetheless pleased to still be in the news more than six weeks later — although there's more snow on the ground, and local schools were closed Monday.

"We couldn't have generated this much publicity with a \$10,000 ad campaign," he said.
