 - *Those who purchase a 12-month or 6-month paid-in-full membership by cash/check receive a 3% savings.*

Lions Club Breaks Ground for Habitat for Humanity Dec. 3

At noon Tuesday, Dec. 3, ground will be broken to start a Habitat Housing project being jointly sponsored by several Lions clubs in Loudon County, the Lions Clubs International Foundation (LCIF), and the Loudon County Habitat for Humanity organization. The home is being built in the Hope Haven Habitat development in Loudon County.

This project is possible thanks to a partnership between LCIF, the charitable arm of Lions Clubs International, and the national Habitat for Humanity organization. This partnership provides funding for homes under the following conditions:

- The home must be for a family with a disabled member(s);
- The local Habitat organization must provide ½ of the required funds and the land;
- The local Lions Club(s) must raise one-quarter of the funding, and
- If these conditions are met, LCIF provides the remaining one-quarter funding.

The three Lions clubs involved, Tellico Village, Loudon and Lenoir City have raised the required funds and will provide volunteer labor to complete the home and permit the family to move in late in the spring of 2014. This is the first project of this type sponsored by Lions Clubs in East Tennessee

The three Loudon County clubs have raised \$17,500, Lions District 12N organizations contributed \$2,500 and LCIF has provided another \$20,000. The balance, \$40,000 and the lot will be provided by the Loudon County Habitat organization.

It is anticipated that, in addition to Lions and Habitat personnel directly involved in the project, the ground

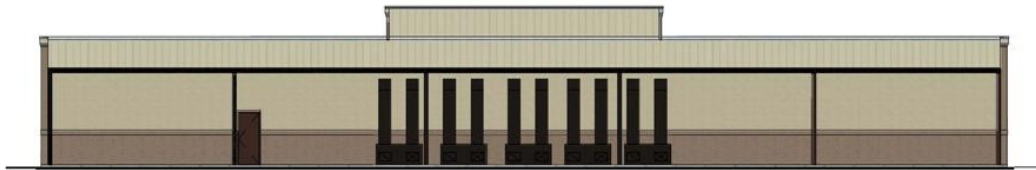
