Golf News and Projects

Many of us driving down Toqua Road have seen the work going on across from the pond by the 10th green. In early December, a sinkhole caused the pump house that services the Toqua golf course irrigation system to shift and lean. This caused the pipe that connects to the well to fracture 15-feet down. The well is 20-feet deep. To stabilize the building, engineers have poured concrete stilts 34 feet deep to connect with the bedrock. They will then be fixing the pipe and well so that water to maintain the course will be available by springtime.

Also in the spring, the Toqua pavilion should be completed. It will be 80 x 50 feet with restrooms and a small kitchen. The pavilion will function as a halfway house, alleviating congestion inside the restaurant, and will be used to host large golf functions. Like the beach pavilion, Toqua's pavilion will also be available for rent for other functions.

Approximately 40% of the budget is for grading and parking. The present cart paths will need to be adjusted and 40 new parking spaces will be added.

The exterior of the Toqua clubhouse will have a makeover this year similar to what was done at Chota Recreation Center in 2013. The Project Implementation Committee (PIC) hopes to present a workable plan this year for updating the Toqua clubhouse restaurant and/or building a new clubhouse in the future.

Kahite should get 60 new golf carts by March 1. By summer a new bridge at hole #3 is planned, which is both functional and will enhance the view driving into Kahite. If you've been to Kahite restaurant recently, you know that Martie Turpin has left and that Golf Operations under Jim West is now running it. Jim hopes to have a qualified contractor in place by April 1. We will miss Martie and thank her for her years of service. Presently, breakfast is being served at 9 a.m., followed by a limited lunch menu that includes hamburgers, fresh made sandwiches, hot dogs, soups, drinks and beer. Jim West retained Maria and Lisa and reports good support from members.

At Tanasi, the nines have been reversed and the halfway house is closed. The restaurant will make a commitment to have a server at the counter for golfers on the turn. All golf carts have had their brakes adjusted. This year golf operations and the golf committee will be looking at the courses at Willow Creek and Green Meadow which switched from bent to hybrid Bermuda on their putting surfaces last summer. Tanasi is budgeted to change June of 2015. More on this topic in months to come.

Toqua has been switching out old batteries for new and adjusting the brakes in their golf cart fleet. Maintenance will acquire a few more fans for circulation around the greens. Bunker renovation will begin in March, after contracting with a bunker architect. Chris Sykes, Toqua golf superintendent, has identified 12-15 in most need to begin this year. This will be a three-year project by an outside firm to get all bunkers in great shape.

By March, there should be new scorecards at all three golf courses, reflecting the new course ratings, slopes, hole handicaps, as well as Tanasi's reversed nines.

A reminder that all of our pro shops are able to take your pre-paid golf deposits in January with a savings of 10%.

Do you remember when you were working and daylight savings time arrived? You would try to get 9 holes in before dark. It seems that most of us are in an 18 hole mode now. But why not consider playing 9 holes this winter when it is cold in the 40s or even a day of sunshine with no wind at 38? It is a lot more bearable for two hours, plus we can keep our games in shape and have camaraderie with our golf groups.

This year the golf committee monthly article will close with a dialogue from one of our pros on a rule situation, a drop procedure, or a mini-lesson tip.

Pro's Corner

Jeff Harrington, Golf Professional, Toqua Golf Club

As I am writing this article, the golf course is snow covered and the immediate forecast calls for highs in the teens tomorrow! What a great time to set some new golfing goals for 2014 as well as brush up on the Rules of the Game. Most of us feel we know the rules well enough not to create any penalty situations, but unfortunately most golfers have determined their own interpretations which can lead to problems. Let's describe a scenario that we see happen quite often each season.

Let's assume you and your weekly foursome are enjoying a round at Toqua. Player A hits a wayward shot into the trees and after searching for five minutes the ball is nowhere to be found. At that point Player A declares the ball lost and heads back down the fairway to play another shot but halfway there someone in the group yells out that they found the ball. Even though the five minute search time had elapsed, Player A happily turns around and plays the hole out with his/her original ball. Happens all the time in casual rounds!

The Rules of Golf allows a player to search for his or her ball for **five minutes**. If after five minutes the ball is not found or identified the player **must** play a ball, **under penalty of one stroke**, as nearly as possible from the same spot from which the original ball was last played.

Here's what really happened to Player A: According to the Rules of Golf the original ball was not a "lost ball", he/she played a wrong ball and incurred a penalty of **loss of hole in match play** or **two strokes in stroke play**. In stroke play, Player A was **disqualified** if he/she did not correct the error before playing from the next tee.

Follow these suggestions to gain a better understanding of the Rules of Golf:

- Become familiar with Rules 1 through 28.
- Keep a copy of the U.S.G.A. Rules of Golf in your golf bag.
- Make a commitment to play by the rules every time you play.

Let's look forward to a great 2014 golf season.
