#### **CAF Fees: Bruce Johnson**

Mr. Johnson discussed CAF fees (completion assurance fee), which are part of the ACC permit process. This fee is in place of a performance bond to ensure the outside of the home is constructed within a certain period of time. Establishing the CAF fee has generated revenue (\$80k last year) and provided a service to property owners to streamline the process. With this comes an obligation to finish the exterior framing or demolish it if construction stops before completion.

Mr. Johnson made a motion to establish a restricted reserve account for CAF fees in the event the POA must exercise that obligation. The fund should have at least 50k and the remaining revenue from CAF fees should be kept in operating cash. The Board voted 7-0 establish a reserve account for CAF fees.

## **FIND YOUR FIT**

To help senior drivers find a better "fit" with their vehicles for comfort and safety, STAYinTV and Tellico Village University are sponsoring CarFit, a safety program designed to help older drivers and their families.

The CarFit program is being conducted in conjunction with the POA's 3rd annual Fall Festival this Friday, October 25th from 10 a.m. to 2 p.m.

"As we age, changes in our vision, flexibility, strength, range of motion and even size and height may make us less comfortable and reduce our control behind the wheel," said Bill Hartman, chair of the event. "CarFit provides older adults with the tools to understand and apply the safety features of their car."

At the CarFit event, trained volunteers will complete a 12-point checklist with each driver. Items checked will include correct position of driver's seat, driver's ability to easily reach pedals and proper adjustment of mirrors.

A Matlock Tire representative will be on hand to check vehicles' tire pressure and fluid levels.

Occupational therapists also will be there to provide consultation, if needed, that can teach drivers how to maintain and improve aspects related to their driving health. The therapist also can provide information to participants addressing individual needs, including information about local community resources on exercise, nutrition and other programs to help keep them safe on the road.



# **PET OF THE WEEK:**

He was picked up as a stray in Sweetwater in mid-September but has not been claimed by anyone. Harry would love to have a family and yard to call his own. If you are looking for a dog with a big smile, please come meet him.

- This is the time of year when shedding becomes a real problem for dog owners. Here are some tips from the AKC: Choose the correct brush suited for your pet by looking at the package's recommendations.
- Select a healthy diet; Omega-3 fatty acids are helpful.
- · Increase water intake to avoid dehydration.
- Visit your vet because some medical conditions can cause excess shedding.
- Take your pup for a full checkup if he is exhibiting exceptional hair loss or is losing hair in patches.
