
LONG RANGE STRATEGIC PLAN

This is the second in a series of articles reviewing the components of the new Long Range Strategic Plan (LRSP). Last week we talked about the new Tellico Village Vision. This week we discuss the financial findings and

recommendations of the LRSP.

Respondents to the Shaping Our Future Questionnaire chose Tellico Village's finances as their number one priority. Over the years we have benefited from balanced budgets and Village growth but the future will present some challenges. Tellico Village growth projections anticipate that between 2030 and 2035 most of the current unsold lots will be purchased causing our Village's assessment revenue to plateau. As build-out (most lots built upon) occurs, our population will approach 13,000 residents, resulting in increased usage of our facilities and increased maintenance costs. These challenges are manageable but we need to be prepared.

In the short term, the LRSP gives priority to those actions and recommendations which are required to maintain infrastructure, preserve financial strength, increase efficiency, reduce costs and eliminate waste. At this time, the Long Range Planning Advisory Committee (LRPAC) is recommending no major capital projects or new amenities. Our palette of amenities benchmarked as best in class. There are several



potential projects that the LRPAC has identified that need further analysis such as a Community Center, Pickleball expansion, Chota replacement, and Wellness Center expansion, among others. The LRPAC supports the Board of Director's ongoing "Repair, Replace, Renovate" theme initiated in 2015.

On November 5th 2019, the Tellico Village Board of Directors accepted the LRSP and specifically these financial related recommendations:

- Establish and formally document a process to review and approve major proposed expenditures
- POA Board and Finance department should develop a rolling 10-year financial plan (currently in progress)
- Conduct a comprehensive operational excellence study to ensure the POA is operating at maximum cost efficiency and effectiveness
- Explore additional and creative revenue generating alternatives
- · All POA Departments create and maintain 10 year long-range plans

Steve Schneider, Tellico Village POA Board Director, had this to say, "The Long-Range Strategic Plan provides a guide to the Board with respect to future maintenance and capital expenditure needs which will be critical as we rebuild our reserves and eventually reach a plateau in assessment revenues. I fully support the LRPC financial recommendations. These actions will build on our past history of maintaining and securing our long-term financial strength."

Marty Inkrott, New Villagers President, added "I think the LRPAC put a lot of quality time, research and strategic thinking in developing this plan that should serve Tellico Village well as a foundation for our future growth and financial stability."

Our financial strength is what sets Tellico Village apart. These forward-looking financial recommendations will enhance our current processes and further secure our financial strength as we address future needs and opportunities.

I am delighted to serve and lead your sports bar this holiday season and beyond. The most frequent questions I am asked are "When are you opening up for breakfast," and "Do you have the NFL Ticket?"

As I have learned, the old Toqua Café was open for breakfast and lunch, but not dinner. Toqua still holds the current ranking as the best place to eat breakfast in Tellico Village. So, we felt that we needed to get lunch and dinner right first, or risk being inconsistent or average. Our goal is to be consistent and exceptional!

Since our Grand Opening a month ago, we are fully staffed and have worked out most of the operational kinks. We have a new menu set to roll out on December 1st that includes exciting lunch items and tasty dinner options. We are also excited to introduce the highly anticipated "Happy Hour" from 2-5pm every day of the week. More details will be announced soon.

Our goal is to continue developing our staff and menus throughout the holidays and begins serving breakfast on Sunday mornings in 2020. Breakfast, like lunch and dinner, will begin with 8-10 items and will evolve over time. We will have comment cards circulating for your feedback. Once Sunday breakfast is established, we plan to serve breakfast Saturday and Sunday mornings. Eventually, we hope to serve breakfast seven days a week. Reservations and catering will be introduced in 2020 as well. Window blinds are currently being selected. WELLNESS CENTER ROOF

The POA is excited to announce we will be soon be removing the tarp from the roof at the Wellness Center. We know everyone is looking forward to a new beautiful roof! Unfortunately, in order to repair the roof while ensuring your safety, we must close the pool. Depending on when the materials arrive, we anticipate repair work will begin within the first two weeks of December. The indoor pool will be closed beginning December 1st to allow us time to prep the area before work begins. We expect the pool will be closed for 6-9 weeks, and anticipate the potential for brief closures of the entire Wellness Center as needed to ensure the safety of our patrons. These closures will be communicated as they occur. Additionally, the section of the walking track located behind the Wellness Center will be closed once construction begins. TV LIONS CELEBRATE 20 YEARS

As Howard Higby and Al Sponholz recall, they did not think the fledgling organization they agreed to join in 1999 would grow to be the outstanding community benefactor it has become in twenty years. They and twenty-four others gathered together at a chartering ceremony in the Christian Life Center of the Community Church to bring to life the Tellico Village Lions Club. In that intervening period, the TV Lions have accomplished much, all of it in benefit to this community, Loudon County, East Tennessee and even reaching into national organizations.

All of this has been accomplished thanks to the hard work of the members of the club, now numbering fifty-five, supported by the residents of Tellico Village and the businesses of Loudon County. The focus of these efforts have been two-fold. First to raise money and secondly, to use it to benefit the community, primarily in the areas of helping solve vision related problems afflicting county residents.

In terms of raising money, the Lions have tried a range of ideas – art auctions, selling brooms and other household items, a variety show, spaghetti dinners, chili/soup dinners, an Oktoberfest, a golf outing and flyer delivery. Of these, the last four, the chili/soup dinner, the Oktoberfest, the golf outing and flyer delivery have proven both popular with village residents and lucrative in terms of the funds raised given the effort to stage or execute them. Over the two decades of existence these fund raisers have generated \$521,445, all of which has been spent in service to the community. In a subsequent post how these funds are used in the community will be discussed in more detail.

All of the club's accomplishments as well as the overall history of the club will be celebrated by the current and, in a few cases, past members of the TV Lions at a gala dinner being held at the Yacht Club on November 22. Joining them will be local notables, from both the community as well as the Lions organizations with which the TV Lions are affiliated. The guest speaker is Past Lions International President Bob Corlew. He is a Tennessean, having spent his career as a Law Professor at Middle Tennessee State University and the Nashville School of Law.

Again, the TV Lions thank the residents of the community for the great support over the course of the last 20 years and hope it will continue, at the same or a greater level, over the course of 20 more years.

KIWANIS CHRISTMAS PARADE

"Heavenly Christmas" is the theme of the annual Madisonville Kiwanis Christmas Parade to be held Saturday, December 7th at 4:00 p.m. The parade will form on Anderson Drive by the Monroe Farmers Co-op and travel North on College Street past the Court House and then follow the route from last year.

The Grand Marshall for the parade is Tennessee State Representative Lowell Russell. Lowell was elected this year to the state Legislature. Originally from Maryville, he resides in Vonore. He is well known in the local area for having served in the Tennessee Highway Patrol.

All floats are eligible to win a cash prize. Judged floats will be parked by the Co-op, non-judged floats will be parked on Anderson Drive. Floats competing for prizes should be in-place for judging by 2:00 p.m. Cash prizes will be awarded for first, second, third place and Judges' Choice. All floats can be judged; churches, civic organizations, business, etc. An application to be judged must be submitted to City Hall by noon Friday before the parade. There are no fees to participate in the judging or the parade.

Four wheel vehicles are not allowed and floats are asked not to throw candy for safety reasons. Candy may be pitched or handed to spectators. In the event of inclement weather, the parade will be held on December 14th

PET OF THE WEEK:

He is about 2 years old, weighs 32 pounds and has a beautiful red/mahogany coat. Boomhauer is being treated for heartworms and is reacting very well to the medication. He is friendly and gets along with other dogs. Although he does love to walk on a leash, he could use a firm hand to teach him some manners. If you would like Boom to be part of your family, please stop by to meet him.

Now that the colder weather is approaching, it's time to review some safety tips. If you keep your dog outside, provide shelter and check on the water bowl to make sure it isn't frozen. If there is a way to safely heat the shelter, all the better. If you walk your dog in the dark, wear a reflective vest. These days, many dog collars have reflective chips on them as well. Bring a flashlight along on your walk. It alerts

drivers in advance there is something of note to look out for up ahead. Check to see what ingredients are in the ice melt you may use on your driveway. Many contain chemicals which can cause burns on your dog's feet. If your dog is particularly sensitive to the cold, booties are sold in many stores. And lastly, as your dog ages, it might be time to buy a sweater. Old bones enjoy the warmth!

Have you been to the MCFA Thrift Store run by volunteers of The Monroe County Animal Friends of Animals (MCFA)? It's located at 3949 Highway 411 in Madisonville (across from Kentucky Fried Chicken). If you haven't been there in a while, you might be missing out on some tremendous bargains. New merchandise arrives daily and is priced to move. Clothing, shoes, furniture, kitchen ware, bedding, appliances, books - we've got it all. Donations are greatly appreciated and are accepted Wednesday – Saturday from 10 a.m. – 3:30 p.m. All proceeds go to help the homeless animals of Monroe County. Shopping hours are Wednesday – Saturday from 10 a.m. – 4 p.m. and worker volunteers are always in high demand. Like us on Facebook for up-to-date sale information or give us call at 423-420-3423.

Please consider offering a foster home to help the pets at Second Chance Pals (SCP), a program of Monroe County Friends of Animals. Foster homes help older and/or sick pets that need more assistance than the typical homeless pet. They often cannot be treated until they have a foster home commitment where they can safely stay until their recovery needs are met. Veterinary care and expenses are provided for their treatments and they are closely monitored. SCP also helps pets who have had to be given up by their owners. Sometimes it's because of a move or because the owner just can't take care of the pet anymore.
