NOVEMBER 14TH BOARD MEETING HIGHLIGHTS

Minutes: The minutes from the November workshop were approved 7-0

Finance Report: Parker Owen presented the report to the board. Recently, Coulter and Justus, P.C. filed the Village's 990 and 990T forms with the IRS and will be posted for viewing soon to the POA website. Currently the Village is running about \$292,000 in revenue above budget. He stated that the Village is still experiencing expense underruns, but these are expected to catch up in the coming months. He also explained that currently there is roughly \$127,000 remaining in the capital fund and Parker doesn't know if that will be spent by year end. He also explained why golf revenue is down for the year. The reason for that is all the rough weather that we experienced in early April and the extremely hot summer.

Budget Review: The 2019 budget and the 2020-2024 five-year plan has gone through 8 different reviews. The 2019 capital plan is roughly 4.5 million dollars, the R&M reserve fund will use 1.996 million dollars. Amenity reserve funding is budgeted at 1.839 million dollars. Water and sewer for 2019 will use a total of \$364,000 and total docks reserve funding is budgeted at \$63,000. The TRDA reserve is a holding account to accumulate lease payment of 400k funding in and 400k funding out. He covered the 2019 assessment and user fee schedule increases and decreases. Parker requested board approval on the 2019 operating

budget, 2019 capital plan, 2019 monthly assessment of \$132.90, reserve plan for funding with withdrawals, financing plan subject to further negotiations with our bank, proposed water and sewer rate increase, pricing plans as contained in the golf, fitness, docks, and RV storage budgets. This was approved 5-2. Acceptance of the 2020 to 2024 five year plan as a planning document and is subject to change based on continued review, was approved 7-0.

HOA: Sue English-Kovar covered recent highlights, upcoming events, and looked at what the HOA has done so far this year. She stated that the HOA is offering 19 different events in November. She also covered their rebranding strategy, and how they are aspiring to be engaged, be informed, and be heard as well as drive the value of the home owner's membership. They also increased general meeting access through different viewing platforms like live streams, radio broadcasts, vimeo, and the ability to view on the HOA website. From this time last year, the renewal rate has gone up 187%. The new HOA board will assume leadership on December 3rd.

Public Works: Jeff Gagley announced that water loss is down. Currently YTD it is sitting at 21.2%. Both new pumps are back in service at the new lift station with the reinforced impellers on both pumps. Also the wet well at Kahite has been recoated.

Golf: Wells McClure gave a background on capillary concrete and what lead him and Jim West to believe that it would prove an asset to the bunkers of the Tanasi course. He reviewed the project up to what they have completed this year and look to complete in the coming year. By completing this project in house, Wells and his dedicated team were able to accumulate total savings around \$90,000.

UNITED WAY KEEPING PEOPLE HEALTHIER

UW Partner Agencies provide service to the community in three primary areas: health, education, basic needs and financial stability. In the first focus area, health, the agencies provide health related services to various segments of the Loudon county population by dealing with unique problems in a variety of areas.

The Loudon County Senior Center and Senior Citizens Home Assistance Service serve over 150 seniors or disabled individuals (including almost a dozen in Tellico Village) with a variety of support services that enable them to maintain an adequate quality of life in their homes.

The Boys and Girls Club of Loudon County provides not only after school activities to school children, but also works on maintaining health by providing nutritious snacks and meals to children, as necessary. This is a complement to the school system managed Panther Pack program that provides healthy food for indigent children over the weekends. The prevention and health program promotes physical activities along with nutrition lessons to insure healthy diets.

The East Tennessee Kidney Foundation provides transportation and related services to indigent dialysis patients insuring that they can receive their lifesaving treatments as required by their health conditions.

The Epilepsy Foundation of East Tennessee has two major programs. The first is an education program designed to makes residents of the county aware of the symptoms and treatments available for those suffering from epileptic seizures. Their second program is providing free bicycle helmets to needy children to protect them in the case of falls; bicycle accidents are one of the major causes of brain injuries that can lead to epilepsy. In addition they help patients with the medications necessary to control their seizures allowing them to have productive lives.

Project Life Saver is a county-wide program that provides ankle or wrist bracelet locator devices that can be worn by individuals of any age with Alzheimer's, autism or other memory disorders, who can wander off and not be able to find their way home. The locator device assists police and other agencies to locate these lost individuals and return them to their homes and safety.

The Hearing and Speech Foundation, although located in Maryville, TN, has a program that is targeted specifically at Loudon County residents, including children. This program rehabilitates donated used hearing aids and makes them available, at very low or no cost, to indigent county residents. The ability of these type individuals to be able to hear after a long period of poor or total hearing loss has, what can almost be considered, a miraculous effect on their quality of life. The service includes, audiological exams, ear molds and hearing aids.

Each of these programs is funded by United Way using the dollars you donate. Even though these are ongoing programs they are reviewed annually by the UW BOD to insure that they are still operated in the most efficient manner possible and are effective in providing the services described.

KAHITE UW EXPERIENCES ANOTHER SUCCESSFUL CAMPAIGN

The Kahite 2018 United Way Campaign is complete and A BIG THANK YOU goes out to all of the Kahite community for making our 2018 Monroe County United Way campaign a success! The Kahite campaign ran for the month of October – just 31 days. In mid-October, team members hosted a Hot Dog Appreciation Night where Kahite residents came and enjoyed a hot dog dinner. Helping to support this event were local businesses including Benton’s, Food City, Kentucky Fried Chicken, United Grocery Outlet, and Smok-N-Bonz BBQ.

The committee’s goal for the year was to receive donations from at least half of the homes in Kahite. That goal was exceeded and reached 111%. Over \$30,000 was collected, which will benefit the 22 charities supported by Monroe County United Way.

It is important to note that United Way of Monroe County returns 99% of all donations received to supported agencies. UWMC owns its own building and leases 80% of that space to others. The rent collected covers all local general and administrative costs of UWMC.

The Dock Captains Committee plans, in the near future, to present a project request to build a 34-slip dock in the Tanasi basin to the POA Board so that it can be built in time for the 2019 boating season. The POA Board, however, views this project request as contingent upon securing a enough commitments. Therefore, if this project is to happen, you need to act now.

If you don't already lease a slip from the POA, but you will need one in 2019, we ask you to contact Karen Davis at the POA offices (865-458-5408 extension 4117, email: kdavis@tvpoa.org) and submit your application together with a \$250.00 deposit as soon as possible. She will then place you on the official wait list for a slip in the community docks either at the Yacht Club or in the Tanasi Basin. If there are sufficient number of applications (and our recent poll indicates that there should be), then we'll take the project request to the Board. Don't delay, act now!

LOUDON COUNTY EARNS NATIONAL SEAL OF APPROVAL

AARC Recognizes Best Places to Retire in the U.S.
