## PROCESS FOR COLLECTION OF DELINQUENT ACCOUNTS

One of the responsibilities of the TVPOA staff and Board is to ensure that monies owed to the POA for assessments or other charges are collected. Seemingly simple on the surface, collections are not always as easy as sending reminders of past due amounts or threatening more severe actions. Combined with the difficulty of dealing with some large investor groups who bought property before the real estate crash of 2008 and failed to meet their obligations on lots that are now worth much less than they paid, collection becomes a very challenging problem. The POA staff and Board recognize that delinquent property owners place a significant financial burden on the organization since the shortfalls in revenue from those that do not pay must be made up by those that do. To address these issues, TVPOA follows a collections process described as follows:

- (Letter) 30 Days Past Due: The collection clerk will send a letter to all property owners who are 30 days delinquent on the last business day of each month. The letter will inform the property owner of their delinquent balance. The letter will state that if the balance is not paid within 15 days, the account will be placed with a third-party collection agency and interest charges will begin to accrue. The letter shows the current amount past due and the total

amount to be paid by the deadline, which includes the next month's assessment.

- (TSI) 45 Days Past Due: The collection clerk will begin interest charges of 18% per annum as authorized under the Covenants and Restrictions. The POA will forward the accounts to Transworld Systems Inc. (TSI). TSI will then start their process of mailing up to 5 letters to the property owners. The letters will be mailed every 10 days for the next 50 days.
- (Lien) 90 Days Past Due: Once the TSI letter process is complete, the collection clerk will suspend the property owner's membership privileges. The collection clerk will file a lien with the Chief Financial Officer's authorization in the appropriate county. A letter is sent with a copy of the registered lien notifying the member of the lien, suspended privileges, and a demand made for the past due amount.
- (Demand Letter) 120 Days Past Due: Thirty days after the lien is filed, the account is turned over to our attorney. He will send the property owner a demand letter. The letter notifies the property owner of the past due balance and informs the member that a lawsuit will be initiated in thirty days if the outstanding balance is not paid.
- (Oath) 150 Days Past Due: Thirty days after the demand letter is sent, the collection clerk will fill out an oath of account against the property with the Chief Financial Officer's authorization. The clerk will send the oaths to the attorney to seek a monetary judgment.
- (Foreclosure) 270 Days Past Due: The collection clerk will fill out an oath of account against the property owner with the Chief Financial Officer's authorization. The clerk will send the oaths to the attorney to seek attachment of property.

Once the process reaches the legal stages, the POA attorneys pursue collections through all legal means that are economically viable. Depending upon the property, the amounts owed, the location of the owners, and other factors, we will commit the appropriate level of resources to the collection efforts. Over the past 11 years, from 2008 through 2018, we have recovered over \$4.00 of revenue for each \$1.00 spent on collections expenses.

## BOARD MEETING HIGHLIGHTS

The February Board of Directors meeting was held last Wednesday, February 20th. After President Bruce Johnson called the meeting to order, the Board voted on the minutes from last month's meeting on January 23rd; the minutes were approved 6-0, with Rick Blough absent. The Board then asked for advisory committee reports. They heard from HOA, Finance, Long Range Planning, Architectural Control, and Public Service.

## **Finance report: Parker Owen, CFO**

### Current Activities:

- Groundbreaking ceremonies for the Toqua clubhouse and Kahite community center on February 13th were well attended and well received.
- The TVPOA audit committee and the outside audit team met on February 14th. Field work will begin in April, and final reporting is scheduled for the May Board meeting.
- Re-bidding of insurance policies is underway.

### Financial Analysis:

#### • Income:

YTD net income is \$181K better than budget  
Golf and recreation saw favorable revenue

#### • Expenses:

Maintenance expenses were below budget  
Water and sewer saw an unfavorable variance due to cost of sewer treatment and warranty work

#### • Capital Improvements:

Master meter software upgrade will be tracked as a 2019 capital plan project  
Approved 77% of 2019 capital plan; on budget for authorized amounts  
Capital projects remaining are about 1/3 golf, 1/3 fitness, 1/3 public works

## **Long Range Planning report: Wayne Enderle**

- Long Range Planning committee provides the POA Board with information and recommendations necessary to plan for future needs of Tellico Village.
- LRPC's Strategic Plan
  - Results from surveys and focus groups have been collected
  - Currently vetting findings and preparing report
  - Final report will be presented to Board for approval in May

## **Architectural Control report: Jeff Gagley**

- ACC has issued 15 building permits YTD, meeting the record of 15 in February 2018.
- The independent living facility is on target for July completion.
  - At the last ACC meeting, requests to add garages and carports and reduce the pool to a large hot tub were approved.

## **Public Works report: Jeff Gagley**

- Replacement of 30 water meters: expected completion by year-end but will likely be an ongoing project.
- Repairs to main road from Niles Ferry to the pavilion: scheduled for July/August.
- Lift stations: all are in operating order.
- Roads management: evaluating four proposals for pavement management.
- Meter reading equipment and software: current units are obsolete. This project has been budgeted for and expected to be installed by April.
- The north fountain has been closed for the winter but is expected to resume operation mid-late March.
- Kahite community center: on time, on schedule, and on budget
  - Skimmed topsoil and filled in with rock
  - Some trees were removed
  - Gravel has been laid and compacted
  - Pad is ready for construction pending weather
- Toqua clubhouse: 3-4 days behind schedule; on budget
  - Following demolition, the area was cleaned, driveway and sidewalks have been cut out, and some trees have been removed
  - Currently waiting for dry weather to continue grading
- Wellness Center dehumidification process:
  - Dehumidifier has been installed, tested, balanced, and is operating smoothly
  - Site has been cleaned up and fence is complete
  - This will be the last update, as the project is 100% complete

- Goal 2: Re-structure guidance and processes needed to more effectively manage Village growth

## LIONS EXPAND LIST OF ACCEPTABLE PILL CONTAINERS

Based on feedback from Matthew 26, the Ohio organization that collects and distributes used pill containers worldwide, the list of acceptable containers has been expanded. In addition to the brown, screw-cap containers previously listed, virtually any plastic container used to store medical type products, vitamins, OTC drugs, etc., are now acceptable.

As in the past, the labels along with any contents must be removed, and the cap or screw lid included. The photo shows examples of three generic types that are accepted, though there are larger- and smaller-sized containers in a variety of colors that are also acceptable.



The Lions continue to accept used eyeglasses and hearing aids.

Glasses should not be damaged and not be in cases. Hearing aids can be in cases and can also be donated with batteries. The simplest way to package any of the three items is in plastic grocery store bags.

There are two places in which these donations can be deposited. The first is in the large drive-up container at the rear of the Welcome Center. Access can be gained by driving around the right side to the old bank drive-up area. The deposit container is located on the center island. The other location where donations can be made is at the Gary Stuart Edward Jones office in Chota Center, opposite the TVCC offices. This can only be accessed during business hours, so the Welcome Center location is likely more convenient and is the preferred drop-off point.

## TV LIONS ADD 12 NEW MEMBERS

## TV LIONS CHILI / SOUP DINNER

You can't yet hear the sounds of plates rattling, vegetables being sliced, ground beef simmering, or the myriad of other noises that accompany preparations for this event – but you will hear them in the near future. They will be emanating from the Christian Life Center of Tellico Community Church in the wee hours of March 12, 2019.

This dinner is the first of five annual fundraising events presented by the Tellico Village Lions. The proceeds support the many community service activities the Lions carry out each year. The key to the success of this and other events is support from Village residents. That annual support translates into almost \$40,000, every cent of which is returned to the community by efforts of the club's 56 members. 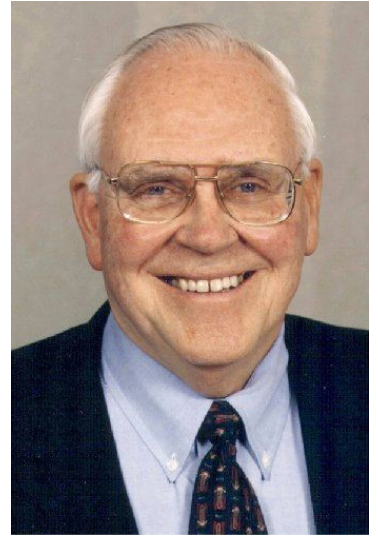

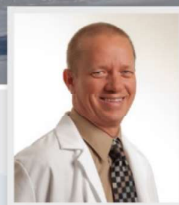

## PET OF THE WEEK:

Archie is a small, 20-lb border collie mix who will steal your heart. He is very shy and quiet but loves to cuddle and be held. He is hesitant when someone approaches but as soon as he realizes you are friendly, he smiles and hopes for a treat (hot dogs are his favorite). Our mission is to provide a second chance to at-risk adult dogs and cats in Monroe County by finding foster or other temporary care until a forever home can be found.



Why should you adopt an older pet? Well, puppies and kittens are a lot of work! Most older dogs from SCP are house broken, socialized, and usually have a calmer temperament. Many senior shelter dogs have already been trained to walk on a leash and come when called. Older dogs can offer comfort and emotional support.

Spring is coming! Check out the MCFA Thrift Store run entirely by volunteers. We have clean, gently used items at great prices. Get an early start on your spring cleaning and donate to the store (and the animals). Donations are greatly appreciated and are accepted Wednesday-Saturday from 10 a.m. - 3:30 p.m. All proceeds help the homeless animals of Monroe County. It's located at 3949 Highway 411 in Madisonville (across from Kentucky Fried Chicken).
