- A proposal is planned to be presented to the Board at the December workshop regarding the new site plan

#### Boat Dock Power Pedestals

- Replaced 31 pedestals in 2019
- Worked with Dock Captains to ensure the new pedestals would meet needs
- Used in-house personnel, saving the POA 15k v. hiring a contractor

#### Pavement Management Survey

- S&ME performed a survey of the roads
- The study confirmed our roads are in good overall condition and our funding to perform long-term maintenance is sufficient

#### TASS Booster Pump

- Low water pressures in Toqua led to the operation of the south booster pump
- Booster pump stabilized water tank levels in Chota and water pressures in Toqua

#### Wellness Center Dehumidifier

- Dehumidifier was replaced early 2019 on schedule and on budget
- New unit operates as intended and controls the temperature/humidity to prevent deterioration of the building

#### Wellness Center Roof

- The Wellness Center roof needed to be replaced due to operational problems at the pool, along with an improperly sized dehumidifier
- In contract with Barge for a standing seam metal roof
- A third-party quality control inspector will verify the roof is installed correctly
- The project must be completed 70 days from when it was bonded, which was November 12th

#### Sewer Study

- Determined the sewer system is capable of meeting current needs, though a few lift stations will be needed in the future
- Identified the storm water infiltration is the biggest contributor to sewer system overloads

#### Sewer Tank Upgrades

- Made tank modifications to minimize infiltration to prevent overloads
- Minimizes operational impacts and limits the POA's direct cost of treating stormwater

#### Minimum Insurance Requirements

- PSAC developing specific insurance requirements for contractors

#### Kahite Paving

- 1.5 miles of Kahite Trail was milled and paved

#### HA5 Paving Rejuvenation

- HA5 was applied to many roads in the Village
- HA5 roads were 5 degrees warmer during freezing temperatures

#### **Finance: Parker Owen / Kevin Ellsworth**

- Revenue: \$179k favorable
- Expenses: \$666k favorable
- Net Income YTD: \$845k favorable
- 2018 tax returns were filed prior to the November 15th deadline and will soon be posted to the POA website

## Replacement for Clayton Taylor's ACC truck

- Mr. Taylor was hit by a driver resulting in the total loss of POA-owned vehicle. The replacement cost was \$35,761 but will only cost the POA \$4,429 after insurance reimbursement.
- Request amount: \$4,429
- No Board approval needed

## Street Striping

- As a part of the ongoing roads maintenance, the striping was scheduled and budgeted for 2019 as a part of Public Works dept budget.
- Request amount: \$52,794
- Board approved 6-0

## Summary of Toqua and Kahite projects

- The total for both projects came in under budget
- The Board also looked at the final summary for the 2020 budget and 10-year plan. The Board approved the 2020 budget and accepted the 10-year-plan. The full summary of the 2020 budget is available to view on the POA website.

### Major change in golf handicapping

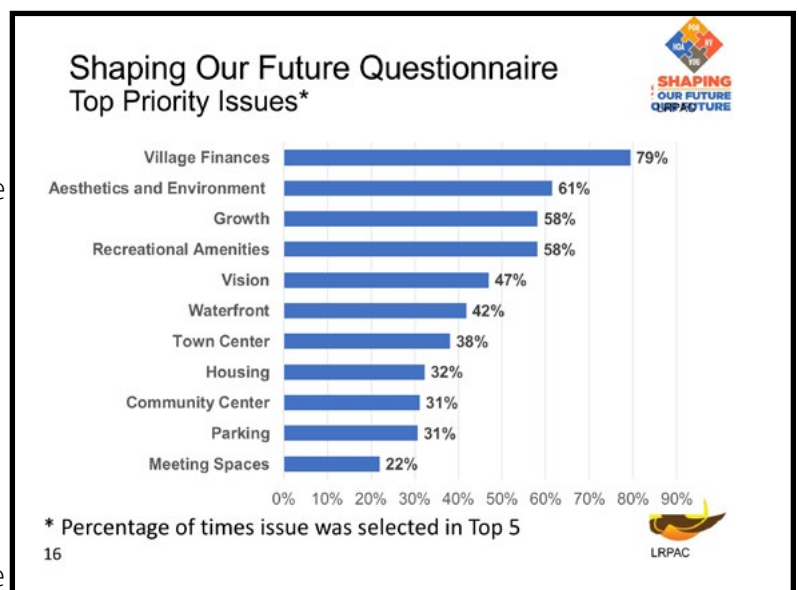
- Effective January 1, 2020

## LONG RANGE STRATEGIC PLAN

*This is the third in a series of articles reviewing the components of the new Long Range Strategic Plan (LRSP). Last week we talked about Finance. This week we discuss Meeting Space and Parking – “Quick Wins”. Next week Meeting Space and Parking – Large Meeting Space Solutions*

How many times have you heard “I couldn’t get a meeting room.” or “I couldn’t find a parking space”? A lot, right? It would seem to the casual observer that Tellico Village may have a Meeting Room and Parking Space Problem. But, after analyzing the data, we determined this may not be the case.

In the Shaping Our Future Questionnaire, respondents listed meeting room and parking as their least two important issues. To the question, “How often has a lack of parking impacted your household’s attendance at an event, dinner, or recreation in TV?” 41% responded “Never” and 33% responded “Rarely” (once or twice a year). Review of meeting room utilization data indicates we have spare meeting room capacity. So, why the disconnect?



We found that apart from large meetings such as New Villagers and HOA or similar group events or clubs

requiring space, Christmas Bazaar or Quilting Club, for example, we don't have meeting room problems. With the exception of large event parking and occasional Chota Recreation and Tanasi parking, we don't have parking problems either. Rather, we have a scheduling efficiency and effectiveness problem. Currently, it takes up to 5 phone calls to 5 different people to schedule a meeting room. Sometimes, in the case of Chota and Tanasi, we schedule so many meetings at the same time, that parking availability is also impacted. We need a better process. We need a better system.

A better process coupled with technology could improve scheduling efficiency and effectiveness. The LRSP recommends the following actions:

- Making one POA employee responsible for all meeting room reservations
- Installing a web-based meeting room scheduling system which allows villagers and clubs to see what meeting rooms are available and make online requests. The system would also take into consideration parking by noting parking required for each meeting request
- Meetings that would exceed parking availability should not be scheduled
- During large events, shuttle buses should be arranged to ferry attendees from overflow lots to the event
- Where appropriate, we should consider using technology to build virtual meeting rooms rather than brick and mortar ones

Tellico Village Board Director, Pat White commented "Going forward, Villagers must make a cultural decision, should we spend massive amounts to expand landlocked facilities or should we develop alternative solutions that meet our needs and maintain our "social fabric"? Working together as a community, we can solve these issues."

HOA President, Ken Litke added, "HOA strives for Villagers to "Be Engaged, Be Informed, Be Heard" and the implementation of appropriate on-line technologies will help further enhance these goals by improving meeting and information access for Villagers."

These short term recommendations for Meetings and Parking Space are what we call "Quick Wins"- fast, easy, inexpensive solutions that have high impact on the issues Tellico Village faces in the near term.

## POA BOARD OF DIRECTORS

At the December 18th Board meeting, the Board will certify the election results and announce the new Board members. ## SMART METER UPGRADES

Loudon Utilities (LU) has announced that they will complete the Advanced Metering Infrastructure (AMI) smart meter upgrade project by mid-December. When the 720 homes in Coyatee, Toqua Greens and Toqua Point are changed in November and December, the AMI upgrades for Tellico Village will be complete.

The new AMI meters provide frequent readings and key service announcements wirelessly directly to LU. For homeowners the meters provide the following benefits:

- Remote meter reading resulting in fewer home visits by LU personnel
- Increased accuracy and more efficient billing processes
- Improved attention to customer concerns
- Immediate and accurate responses to customer issues including potential hot wires and fire hazards.

One Tellico Village resident has already reported that a high temperature reading on her AMI meter uncovered a potentially dangerous exposed-wiring issue in her home. Until the LU service people appeared at her door in response to the wireless reading they received, the homeowner had no idea that electrical malfunction could have resulted in a house fire.

## WELLNESS CENTER ROOF

The POA is excited to announce we will be soon be removing the tarp from the roof at the Wellness Center. We know everyone is looking forward to a new beautiful roof! Unfortunately, in order to repair the roof while ensuring your safety, we must close the pool. Depending on when the materials arrive, we anticipate repair work will begin within the first two weeks of December. The indoor pool will be closed beginning December 1st to allow us time to prep the area before work begins. We expect the pool will be closed for 6-9 weeks, and anticipate the potential for brief closures of the entire Wellness Center as needed to ensure the safety of our patrons. These closures will be communicated as they occur. Additionally, the section of the walking track located behind the Wellness Center will be closed once construction begins. ## GOLF COURSE SUPERINTENDENTS

Our Golf Department has been hard at work to maintain our Audubon certification.

At Kahite, Jordan Clark made turkey feeders and placed them along the tree line of golf hole #17. He says there has been some activity but nothing physically thus far. In addition, Jordan planned the landscaping for the new clubhouse annex with hopes of attracting desirable wildlife in the future.

Wells McClure at Tanasi, implemented a slow release fertilizer, allowing his team to mow fairways twice per week instead of three times weekly as in the past. This saved an average of 14 gallons of diesel per week in the growing season, which is late May through late September. Wells estimated the total savings for the Village to be 224 gallons of diesel fuel. He also has several other plans in the works, such as building a bat box. If successful, there would be less flies, gnats, and mosquitos on the golf course. Wells also plans to build two more mallard nesting tubes this winter.

At Toqua, Chris Sykes is often addressing fallen trees on the course following storms. He would like Village residents to be aware that Audubon International teaches that leaving downed trees in out-of-bound areas of the course is desirable. The downed trees provide nesting opportunities and protection for wildlife. Chris expects to obtain donated wildflower seed to start a butterfly garden at Toqua Golf Course in spring 2020.

If you see these savvy superintendents on the golf course, thank them for supporting a naturalized environment on our golf courses.

## LIONS CLUB

At a gala dinner held at the Yacht Club, the TV Lions gathered to celebrate a momentous occasion: 20 years of service to Tellico Village, Loudon County, East Tennessee and nationwide. Joined by District 12N Governor Carol McDonald and her husband Former District Governor Bill McDonald, and TN State House District 21 Representative Lowell Russell, the TV Lions recalled the club's history and significant accomplishments achieved over the period.

Starting with a charter membership of 26, the club now has 57 members. These current and former members have accomplished a notable range of service projects with hard work and dedication, as well as support from the residents of Tellico Village and the businesses of Loudon County. These accomplishments were recognized by the King Lion, Larry Elder as well as the guest speaker, Lion Bob Corlew, Former Lions International President. In his comments, he noted significant events that had occurred in 1999, the year in which the TV Lions were chartered, as well as accomplishments, that he had seen performed by Lions in over 110 countries that he visited during his tenure. After the comments by Lion Corlew, a Necrology Ceremony was held honoring nine members of the club who had passed away.

Key to executing service projects is having financial strength, which means designing projects that can attract participants and raise fund at a level commensurate with the effort involved. To do this the TV Lions



have tried a range of ideas – art auctions, selling brooms and other household items, a variety show, spaghetti dinners, chili/soup dinners, an Oktoberfest, a golf outing and flyer delivery. Of these, the last four, the chili/soup dinner, Oktoberfest, the golf outing, and flyer delivery have proven both lucrative and popular with Village residents. Over two decades, these fundraisers have generated \$521,445, all of which has been spent in service to the community. Currently, funds raised annually total about \$50,000.

The major single use of funds, approximately \$112,000 over the 20-year period, has been the free eye examination and glasses program for indigent residents of Loudon County. Done in conjunction with the Good Samaritan Center in Lenoir City and the Good Shepherd Center in Madisonville, approximately 25 indigent residents are examined each month by an optometrist, who is a member of the Lions team, and given free examinations and glasses.

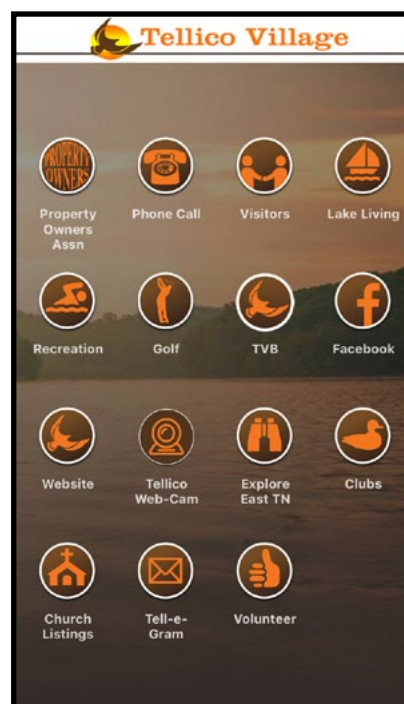
The other large vision program these funds support is vision screening in the schools. At the K – 12th grade level over 60,000 students have been screened with approximately 3000 students referred for possible vision problems detected in the screening. The other portion of this vision program is screening of children, six and under, in pre-schools and day care centers. Of the 11,000 children screened in this program, over 500 have been referred for further examination and treatment.

The funds remaining after these vision programs are fully funded are used as contributions within Lions Mission Area, Lions Mission Related Areas, Local Charities and Community Service. Each of these areas receive a fund amount commensurate with need as well as importance to the overall mission of the club. The Lions mission, which includes District 12N charities, is currently funded at a level of \$9,000/year, mission-related at about \$5,000/year and the other two at about the same level, \$5,000/year.

Members of the club are justifiably proud of the myriad of accomplishments over the life of their organization. They hope that with the same level of member dedication and community support they can, as Lion Corlew indicated in his talk “continue to serve the community in the exemplary fashion which they have done for twenty more years.”

## KIWANIS CHRISTMAS PARADE

"Heavenly Christmas" is the theme of the annual Madisonville Kiwanis Christmas Parade to be held Saturday, December 7th at 4:00 p.m. The parade will form on Anderson Drive by the Monroe Farmers Co-op and travel North on College Street past the Court House and then follow the route from last year.

The Grand Marshall for the parade is Tennessee State Representative Lowell Russell. Lowell was elected this year to the state Legislature. Originally from Maryville, he resides in Vonore. He is well known in the local area for having served in the Tennessee Highway Patrol.

All floats are eligible to win a cash prize. Judged floats will be parked by the Co-op, non-judged floats will be parked on Anderson Drive. Floats competing for prizes should be in-place for judging by 2:00 p.m. Cash prizes will be awarded for first, second, third place and Judges' Choice. All floats can be judged; churches, civic organizations, business, etc. An application to be judged must be submitted to City Hall by noon Friday before the parade. There are no fees to participate in the judging or the parade.

Four wheel vehicles are not allowed and floats are asked not to throw candy for safety reasons. Candy may be pitched or handed to spectators. In the event of inclement weather, the parade will be held on December 14th.

All pet animals adopted from the shelter are spayed or neutered, wormed, have age appropriate vaccinations and testing, and are microchipped with registration. Cats are litter box trained. The adoption fees are \$50 over 1 year old and \$60 under 1 year old.

The Monroe County Animal Shelter is located at 170 Kefauver Lane in Madisonville (behind Wal-Mart) and is open Tuesday – Friday from 11 – 4:30 and Saturdays from 11 – 2. The shelter is closed to the public on Sunday and Monday. Please consider offering a foster home to help the pets at Second Chance Pals (SCP), a program of Monroe County Friends of Animals. Foster homes help older and/or sick pets that need more assistance than the typical homeless pet. They often cannot be treated until they have a foster home commitment where they can safely stay until their recovery needs are met. Veterinary care and expenses are provided for their treatments and they are closely monitored. SCP also helps pets who have had to be given up by their owners. Sometimes it's because of a move or because the owner just can't take care of the pet anymore.
